

# Schedule of Fees and Charges for Santa Clara County Airports

On each January first of every year, all rates in Section A. "County Based Aircraft" and Section B. "Non- Based Aircraft" for the ensuing twelve (12) months shall be adjusted upward or downward in the same percentage proportion that the Consumer Price Index of the San Francisco-Oakland area of the United States Department of Labor, Bureau of Labor Statistics, increases or decreases over the Consumer Price Index of August 2000.

All fees are rounded to the nearest fifty cents (\$.50).

All aircraft weights referenced in this document are defined by the aircraft manufacture and/or the Federal Aviation Administration (FAA) as the certified maximum gross take-off weight.
